

# HAUPPAUGE'S END-USER LICENSE AGREEMENT FOR WINTV APPLICATION

Version 1.1 May1, 2012

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:

Hauppauge's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Hauppauge Computer Works, Inc. for the Hauppauge software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Hauppauge, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

## 1. GRANT OF LICENSE.

The WINTV ("SOFTWARE PRODUCT") application is licensed as follows:

### (a) Installation and Use.

Hauppauge Computer Works, Inc. grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a Hauppauge hardware WinTV product ("WINTV HARDWARE") for which the SOFTWARE PRODUCT was designed. For each WINTV HARDWARE, you must own an original Hauppauge manufactured SOFTWARE PRODUCT installation CD-ROM. You may not use a SOFTWARE PRODUCT installation CD-ROM on multiple WINTV HARDWARE products.

### (b) Backup Copies.

Only the original CD-ROM provided by Hauppauge can be used to install SOFTWARE PRODUCT. Software updates ("SOFTWARE UPDATE") might be provided by Hauppauge from time to time and can be downloaded from the Hauppauge website only. But software updates will require the original CD-ROM to completely install the SOFTWARE UPDATE.

## 2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

### (a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.

### (b) Distribution.

You may not distribute registered copies of the SOFTWARE PRODUCT to third parties. You may not use a SOFTWARE PRODUCT installation CD-ROM on multiple WINTV HARDWARE products.

### (c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

### (d) Rental.

You may not rent, lease, or lend the SOFTWARE PRODUCT.

### (e) Support Services.

Hauppauge Computer Works, Inc. may provide you with support services related to the SOFTWARE PRODUCT ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA.

### (f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT.

## 3. TERMINATION

Without prejudice to any other rights, Hauppauge Computer Works, Inc. may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

## 4. COPYRIGHT

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by Hauppauge Computer Works, Inc. or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the SOFTWARE PRODUCT is the property of the respective content

owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by HAUPPAUGE.

#### **5. NO WARRANTIES**

Hauppauge Computer Works, Inc. expressly disclaims any warranty for the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, noninfringement, or fitness of a particular purpose. Hauppauge Computer Works, Inc. does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within the SOFTWARE PRODUCT. Hauppauge Computer Works, Inc. makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program. Hauppauge Computer Works, Inc. further expressly disclaims any warranty or representation to Authorized Users or to any third party.
